#### Terms and Conditions:

- 4. Overdue amounts shall be subjected to an interest at a rate of 8.5% per month, calculated from the amount is overdue until date of payment.
- 5. If any legal or other action can be taken by the college to recover any amount due in terms of this agreement, the applicant or student shall be liable for all costs, including but not limited to collection commission, attorney / clients, tracing costs etc
- 6. Mallicious damage to property and/or property of the NORTHWEST MACHINES OPERATORS MINING SCHOOL will be regarded in a most severe light and may result in claim for damages and /or expulsion of the student(s)responsible for the college, interest will be charged at a rate of 2% per month should any amount in respect to any damages claims is not settled withing 30 days of such claim. any such expulsion will not absolve the student /parent from paying the relevant fees in terms of our contract.
